The District Attorney of Montgomery County, by this Information charges that between Sunday, the 16th day of March, 2014, and Thursday, the 6th day of August, 2015, in the Counties of Montgomery, Dauphin, and Philadelphia, Kathleen Granahan Kane did commit the crimes herein,

COUNT 1: **PERJURY**
184902A -- Felony 3rd DEGREE

Did, in an official proceeding, make a false statement under oath or equivalent affirmation, or did swear or affirm the truth of a statement previously made, when the statement was material and she did not believe it to be true.

COUNT 2: **FALSE SWEARING-OFFICIAL PROCEEDING**
184903A1 -- Misdemeanor 2nd DEGREE

Did make a false statement under oath or equivalent affirmation, or did swear or affirm the truth of such a statement previously made, when she did not believe the statement to be true, and this falsification occurred in an official proceeding.

COUNT 3: **OBSTRUCTING ADMINISTRATION OF LAW OR OTHER GOVERNMENTAL FUNCTION**
185101 -- Misdemeanor 2nd DEGREE

Did intentionally obstruct, impair or pervert the administration of law or other governmental function by force, violence, physical interference or obstacle, breach of official duty or any other unlawful act.

COUNT 4: **OBSTRUCTING ADMINISTRATION OF LAW OR OTHER GOVERNMENTAL FUNCTION**
185101 -- Misdemeanor 2nd DEGREE

Did intentionally obstruct, impair or pervert the administration of law or other governmental function by force, violence, physical interference or obstacle, breach of official duty or any other unlawful act.

COUNT 5: **CRIMINAL CONSPIRACY**
18903A -- Misdemeanor 2nd DEGREE

With the intent of promoting or facilitating the commission of the crime of OBSTRUCTING ADMINISTRATION OF LAW OR OTHER GOVERNMENTAL FUNCTION, did unlawfully agree with ONE OR MORE UNINDICTED CO-CONSPIRATORS that they or one or more of them would engage in conduct which would constitute such crime, or an attempt or solicitation to commit such crime or agreed to aid one or more of them in the planning or commission of such crime or of an attempt or solicitation to commit such crime and did an overt act in pursuance thereof.

COUNT 6: **OFFICIAL OPPRESSION**
1853011 -- Misdemeanor 2nd DEGREE

Did, while acting or purporting to act in an official capacity or while taking advantage of such actual or purported capacity, and knowing that her conduct was illegal, subject another to arrest, detention, search, seizure, mistreatment, dispossession, assessment, lien, or other infringement of personal or property rights.

COUNT 7: CRIMINAL CONSPIRACY
18903A -- Misdemeanor 2nd DEGREE

With the intent of promoting or facilitating the commission of the crime of OFFICIAL OPPRESSION, did unlawfully agree with ONE OR MORE UNINDICTED CO-CONSPIRATORS that they or one or more of them would engage in conduct which would constitute such crime, or an attempt or solicitation to commit such crime or agreed to aid one or more of them in the planning or commission of such crime or of an attempt or solicitation to commit such crime and did an overt act in pursuance thereof.


COUNT 8: OFFICIAL OPPRESSION
1853012 -- Misdemeanor 2nd DEGREE

Did, while acting or purporting to act in an official capacity or while taking advantage of such actual or purported capacity, and knowing that her conduct was illegal, deny or impede another in the exercise or enjoyment of any right, privilege, power or immunity.

COUNT 9: CRIMINAL CONSPIRACY
18903A -- Misdemeanor 2nd DEGREE

With the intent of promoting or facilitating the commission of the crime of OFFICIAL OPPRESSION, did unlawfully agree with ONE OR MORE UNINDICTED CO-CONSPIRATORS that they or one or more of them would engage in conduct which would constitute such crime, or an attempt or solicitation to commit such crime or agreed to aid one or more of them in the planning or commission of such crime or of an attempt or solicitation to commit such crime and did an overt act in pursuance thereof.

All of which is against the Acts of Assembly and the peace and dignity of the Commonwealth of Pennsylvania.
