



MOTION TO WITHDRAW AS COUNSEL

4. I have completed all duties and obligations owed to Ms. Kane as her counsel under the terms of our retention agreement.


5. Pursuant to Pennsylvania Rule of Criminal Procedure 120, leave of Court is required for counsel to withdraw his appearance.
