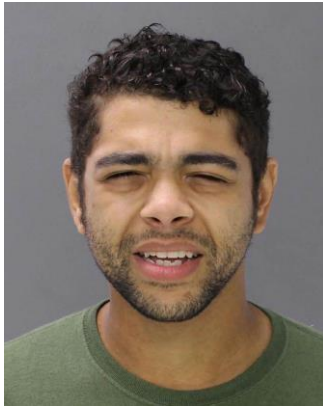

DYLANN BRAGG OF GLENSIDE CHARGED WITH POSSESSING CHILD PORNOGRAPHY

NORRISTOWN, Pa. (Oct. 5, 2018) — Montgomery County District Attorney Kevin R. Steele, Abington Township Police Chief Patrick Molloy and the Pennsylvania Internet Crimes Against Children (ICAC) Task Force announce the arrest of Dylan Bragg, 27, of Glenside, for felony charges of Possession of Child Pornography and Criminal Use of a Communication Facility.

On Aug. 9, 2018, the National Center for Missing and Exploited Children received a cybertip from an individual who reported seeing child pornography on the defendant's cell phone. Abington Township Detective Rick Beaghley, a member of the ICAC Task Force, investigated the complaint. On Oct. 4, 2018, a search warrant was served on Bragg. The search of the defendant's cell phone found more than 100 images of children between the ages of 3 and 13 in various stages of nudity, with numerous images showing the minors engaged in indecent contact with other children and adults.

Bragg was arraigned before Magisterial District Judge Juanita Price, who set bail at \$99,000 cash and ordered him to have no unsupervised contact with children and have no Internet usage. The defendant was unable to make bail and was remanded to

the Montgomery County Correctional Facility. A preliminary hearing is scheduled for 2 p.m., Oct. 15, 2018, before Judge Price.

Major Crimes Detectives of the Montgomery County Detective Bureau, along with specially trained and sworn detectives from police departments in Montgomery County, routinely work with the ICAC Task Force to protect children from Internet predators by aggressively and proactively investigating Internet crimes that exploit children.

The case will be prosecuted by Assistant District Attorney Matt Brittenburg.
