TYSHAUN HARVEY WANTED ON FIRST-DEGREE MURDER CHARGES FOR THE MAY 29TH MURDER IN POTTSTOWN; A \$5,000 reward is being offered for information leading to arrest.

NORRISTOWN, Pa. (June 16, 2022) — Montgomery County District Attorney Kevin R. Steele and Pottstown Police Chief Mick Markovich announce an arrest warrant has been issued for Tyshaun Harvey, 21, of Pottstown, who is wanted for the May 29, 2022 murder of 22-year-old Nahmer Baird in Pottstown. A \$5,000 reward is being offered for information that leads to Harvey's arrest.

The murder occurred Sunday, May 29, 2022, at approximately 8:08 p.m. Pottstown Police responded to a reported shooting in the 400 block of West Street. They arrived to find Baird in the driver's seat of a white Nissan Sentra, suffering from multiple gunshot wounds. Baird was pronounced dead at Pottstown Hospital.

A joint homicide investigation was launched by Montgomery County Detectives and Pottstown Police. The investigation found that a black Chrysler 300 owned and drive by Harvey was following the white Nissan Sentra driven by Baird through the streets of Pottstown for 40 minutes before there was an exchange of gunfire between the vehicles' occupants at Locust Alley and West Street. The investigation found that Baird's vehicle had attempted to avoid Harvey's vehicle throughout that time, but Harvey would find and follow the Sentra again. At Locust Alley and West Street, where the shooting took place, numerous fired cartridge casings were recovered.

After the shooting, Baird's vehicle then traveled eastbound on West Street for approximately two blocks before crashing head-on into a Dodge pickup truck. The Chrysler 300 was recovered in Pottstown by detectives and was found to have four bullet strikes to the front and passenger side of the vehicle.

Harvey is 5-foot, 5-inches tall and weighs approximately 140 pounds. He has brown hair and brown eyes. Harvey should be considered armed and dangerous. If anyone sees him, do not approach him, and immediately call 911.
