## **WARRANTS ISSUED FOR CODY REED AND MARQUISE JOHNSON FOR FIRST-DEGREE MURDER RELATED TO KILLING OF DAQUAN TUCKER;**

**Offering Up To \$10,000 Reward for Information**

THE MONTGOMERY COUNTY DISTRICT ATTORNEY'S OFFICE is seeking information leading to the apprehension of CODY REED and MARQUISE JOHNSON who are wanted on FIRST-DEGREE MURDER charges related to the killing of 35-year-old Daquan Tucker. The victim's body was found on March 3, 2023, adjacent to the Schuylkill River Trail, at the border of West Norriton Township and Norristown, PA.

NORRISTOWN, Pa. (March 14, 2023) — Montgomery County District Attorney Kevin R. Steele and West Norriton Police Chief Michael Kelly announce arrest warrants for First-Degree Murder and Robbery have been issued for Cody Reed, 23, of Norristown, and Marquise Johnson, 23, of Philadelphia, for the murder of Daquan Tucker, whose body was found in the woods, about 100 feet off of the Schuylkill River Trail on the border of West Norriton and Norristown. The District Attorney is offering a \$10,000 reward for information leading to the arrests and convictions of Reed and Johnson.

Both men are wanted on counts of First-Degree Murder, Second-Degree Murder, Third-Degree Murder, Robbery, Conspiracy to Commit Murder, Conspiracy to Commit Robbery, Person Not to Possess a Firearm and related charges.

The victim was found at approximately 9 a.m., March 3, 2023, after West Norriton Police responded to a 911 call from a bicyclist who spotted what looked like a body between the trail and the Schuylkill River. Police arrived to find Tucker's body about 100 feet from the trail down a steep embankment. The ensuing investigation by West Norriton Police and Montgomery County Detectives found that Tucker arrived at Reed's residence a little after 7 p.m., and the three men walked toward the Schuylkill River Trail, close to where Tucker's body was found. Tucker, Reed and

Johnson, all of whom knew each other, then went on the trail, where Tucker was shot multiple times.

Reed is a Black male with black hair and brown eyes, stands 6-feet, 2-inches tall, and weighs approximately 200 pounds. Johnson is a Black male with black hair and brown eyes, stands 5-feet, 6-inches tall, and weighs approximately 170 pounds. Both men should be considered armed and dangerous. Anyone who sees either of them should call 911. Anyone with information about Reed's or Johnson's whereabouts should call the West Norriton Police at 610-630-1701 or Montgomery County Detectives at 610-226-5553. Anonymous text tips can be submitted using MontcoCrimeTips on the STOPit! app. The STOPit! app can be downloaded for free from the App Store for iPhones or Google Play for Androids, then use code MONTCOPA to get the Montgomery County version of the app.
