**Ten males, one female arrested in overnight deadbeat sweep by Montco Sheriff's Office**

**Norristown, Pa., (February 3, 2016)** – Montgomery County Sheriff Sean P. Kilkenny announced that sheriff's deputies arrested 11 deadbeat parents, who owed \$126,218.63 in child support arrearages for 16 children, during an overnight sweep on Wednesday, February 3, 2016.

“One of the Sheriff's Office priorities is to insure that deadbeat parents support their families,” said Sheriff Sean Kilkenny. It is a testament to the professionalism of our deputies that our office does not miss a beat on rounding up 11 deadbeats spread throughout the county, on the same day as the Cosby hearing.”

Two teams of deputies, assisted by K9s, swept through Blue Bell, Glenside, Ambler, Norristown, King of Prussia, and other areas starting at 1:00 a.m., without any major incidents.

The following defendants are in custody, and are awaiting a hearing:
