Montco Sheriff arrests nine domestic violence offenders and deadbeat parents in overnight sweep

Norristown, PA, (October 19, 2016) – Montgomery County Sheriff Sean P. Kilkenny’s deputies arrested nine offenders wanted for various assault charges, child endangerment and nonpayment of child support, during an overnight raid, as part of the 14th Annual National Family Violence Apprehension Detail also known as the “SWEEP.”

“We have a special team of deputies that serve domestic violence related court documents every day,” said Kilkenny. “However, participating in this huge effort, during Domestic Violence Awareness Month, helps to bring national awareness and gets violent offenders off the street.”

The national sweep is a collaborative effort, which includes approximately 250 law enforcement agencies in 26 states. Warrants that are included in the national sweep are domestic violence crimes such as harassment, assault, burglary, criminal mischief and criminal mistreatment. Also included on the list of crimes is child abuse, restraining and stalking order violations, interfering with making 911 calls, obstruction of telephone calls and non-payment of child support.

“Supporting domestic violence victims with compassion is one of my top priorities,” said Kilkenny. “We also escort victims, who are in fear of confronting their abusers during court hearings, throughout the courthouse and to their cars. We also donate phones to the Women’s Center and help support Laurel House’s domestic abuse hotline.”

Two teams of sheriff’s deputies and command staff, including K9s, tracked across Norristown, Pottstown, Lansdale, Harleysville, Willow Grove, Collegeville, and other areas starting at 12:30 a.m. with a list of offenders, some of which had multiple offenses. All defendants are being held in the Montgomery County Correctional Facility or the Courthouse Detention Center.

Four defendants were arrested for various domestic violence charges:

- Justin Fink of 3383 Church Rd., Gilbertsville, Pa., was arrested for simple assault on his girlfriend.
- Roseann Anderson of 811 Noble St., Norristown, Pa., was arrested for endangering the welfare of her children.
- Michael Robinson of 12 Pheasant Rd., Norristown, Pa., was arrested for statutory sexual assault.
- Jonah Wheaton of 770 Logan St., Apt. B 303, Norristown, Pa., was arrested for simple assault on his girlfriend.

Five Domestic Relations Office defendants arrested for nonpayment of child support:

- Erik Dominguez of 1020 Willow St., Norristown, Pa., owes \$7,840.67 for two children.
- Glenn Dransfield of 1250 Queen St., Pottstown, Pa., owes \$6,376.91 for one child.
- Nicholas Mongan of 121 Salem Rd., Schwenksville, Pa., owes \$12,348.37 for two children.
- Robert Richey of 1693 Sheffield Dr., Blue Bell, Pa., owes \$16,312.15 for three children.
- Lowell Scheetz of 106 Everett Ave., Willow Grove, Pa., owes \$12,203.36 for one child.
