Twelve deadbeat parents arrested in overnight child support raid

Norristown, PA (December 15, 2016) – Twelve dads, who collectively owed \$152,297.12 in child support arrearages for 18 children, were arrested by Montgomery County Sheriff's Office deputies on December 14, 2016 during an overnight sweep. One of the defendants had a negative balance, but had failed to appear for court dates related to his case.

“Defendants need to be aware that they can be arrested for missing court dates, as well as arrearages in child support payments,” said Sheriff Sean P. Kilkenny. “If you were given a hearing date and didn’t show up, you should call our Warrants Division or Domestic Relations to resolve your case so that a warrant isn’t issued.”

Following is a list of the defendants that were arrested during the sweep:
