

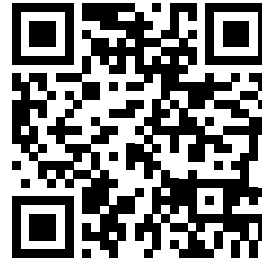
## About the Course

*The Course in Community Planning* covers the fundamental information that municipal officials and planning commission members need to carry out their responsibilities and do an effective job. The course will address the role of planning in local government and how planning commissions relate to the governing body, zoning hearing board, and zoning officer. Specific topics include basic knowledge of the *Pennsylvania Municipalities Planning Code*, comprehensive planning, plan implementation (including zoning, subdivision, and land development regulation), official mapping, and how effective planning commissions approach their responsibilities. The course is designed for both new and experienced participants. It was developed by the Pennsylvania Chapter of the American Planning Association and Penn State Extension Service through their training agency, Pennsylvania Municipal Planning Education Institute (PMPEI). The course is taught by certified PMPEI instructors.

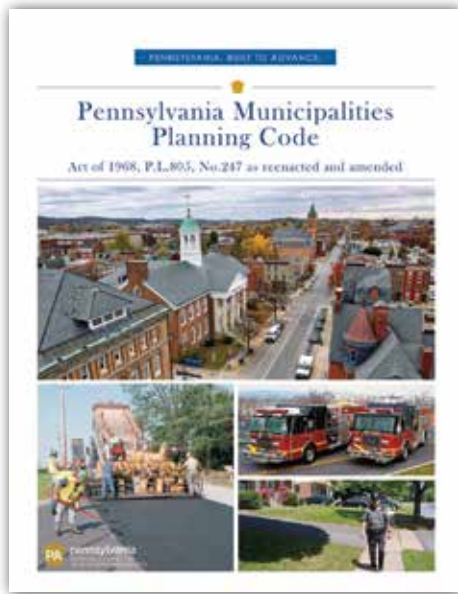

Tuition is \$110 per person. Municipalities with a current planning assistance contract with MCPC are eligible for a discounted rate of \$90. The sponsor reserves the right to cancel and refund tuition if insufficient registrations have been received.
