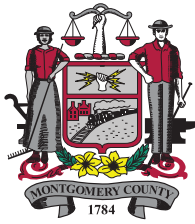

Professional Photography Session Permit

Lower Perkiomen Valley Park and adjoining trails (southern section of the Perkiomen Trail, the Audubon loop and the Schuylkill River Trail within Montgomery County) have become a favorite location for professional photographers.

Photography sessions by a commercial photographer costs **\$50.00** for up to two hours. This fee is to be paid in advance, at the time of registration. Checks should be made out to "County of Montgomery" and mailed with this form to Lower Perkiomen Valley Park; PO Box 972, Oaks, PA 19456.

- This fee is non-refundable, no matter what the weather or park conditions.
- This fee and permit does not guarantee exclusive access to any part of the facility.
- This fee and permit does not guarantee an exclusive time frame, other activities may be taking place in the facility at the time of your session.

Requirements

- The physical site may not be altered in any way during the photo shoot.
- Any temporary props/scenery brought on site for the shoot must be completely removed at the end of site. All trash/debris must be removed.
- Trail traffic may not be stopped nor other users of the Parks or Trails be disturbed during the shoot.
- Park staff has the authority to end a shoot if they feel there is a dangerous scenario or wildlife is being harassed.
- Photo sessions are limited to the Park's open hours and in areas open to the public. Natural areas are entered at your own risk.
- All Montgomery County rules and regulations apply. All signage must be obeyed. Drones are not permitted.
- There are NO ALCOHOLIC BEVERAGES allowed during photo shoots. If you have any with you, keep them in the vehicle and do not consume them while you are in the Park or on the Trails.
