Twelve arrests in Montco Sheriff's overnight deadbeat parent raid

Norristown, Pa. (May 24, 2017) – Sheriff Sean P. Kilkenny led an overnight deadbeat parents sweep that led to 12 arrests. Ten men and two women collectively owe \$95,580.11 in child support arrearages for 23 children.



Three teams of deputies and K9s covered areas from Pottstown to Philadelphia. There were no incidences with the exception of a few foot pursuits.

“We covered a lot of territory and achieved great results in a little over five hours,” said Kilkenny. “I’m proud of our teams, and am happy to have helped these children get what they deserve.”
