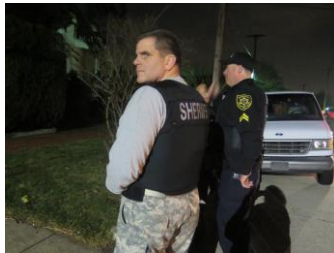

#### **Eight arrests in Montco Sheriff's deadbeat parent raid**



**Norristown, Pa. (February 9, 2018)** – Eight men, who collectively owe \$61,191.44 in child support arrearages for 10 children, were arrested during an overnight deadbeat parent raid.

A team of deputies, including a K9 unit, covered Montgomery County from 12:30 a.m. to 6:30 a.m. One defendant attempted to hide and, the Pottstown Police Department was called to the scene of another defendant who had a grow operation of marijuana in his room.

Following is a list of the defendants that were arrested during the sweep, and are awaiting a hearing:
