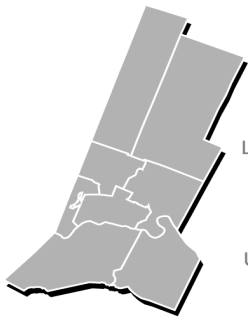

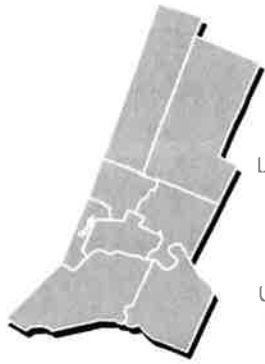

### **RESOLUTION OF SUPPORT**

**Wherefore**, be it resolved that: at the meeting of the Pottstown Metropolitan Regional Planning Committee on September 26, 2018 the following resolution was proposed and approved:

**Whereas** the Municipalities of Pottstown and West Pottsgrove participate in the Pottstown Metropolitan Regional Planning organization, and

**Whereas** the Municipalities of Pottstown and West Pottsgrove have identified the area south of Main Street, west of Hanover Street, and East of the Stowe Interchange of PA State Route 422 as an area designated for redevelopment, and

**Whereas** the Municipalities Planning Code, Act 247 enables those municipalities that participate in regional planning to prepare a Specific Plan that specifies the type and intensity of development along with strict design criteria in order to ensure high quality development at its highest and best use, and

**Whereas** the municipalities of Pottstown and West Pottsgrove have agreed to work together to jointly prepare the Keystone Economic and Employment Plan (KEEP) in accordance with the guidelines found in Article XI of the Municipalities Planning Code for Specific Plans, and

**Whereas** it is the purpose of KEEP to promote uses that expand employment opportunities through new residential/non-residential mixed-use development; and

**Whereas** it is further the purpose of the KEEP to promote strategic infrastructure investments, the most important being the extension of Keystone Boulevard, and

**Whereas** it is also the purpose of KEEP is to maximize partnership opportunities with the Montgomery County Community College's Sustainability & Innovation Hub in addition to County and State government, and

**Whereas** the Municipalities of Pottstown and West Pottsgrove have signed a Memorandum of Understanding (MOU) that will insure their mutual cooperation in the implementation of KEEP.

**Now therefore be it resolved** that the Pottstown Metropolitan Regional Planning Committee commends Pottstown and West Pottsgrove for their willingness to work together for the common good.

**Now therefore be it further resolved** the Pottstown Metropolitan Regional hereby adopts this resolution of support for the Keystone Employment and Economic Plan (KEEP).
