

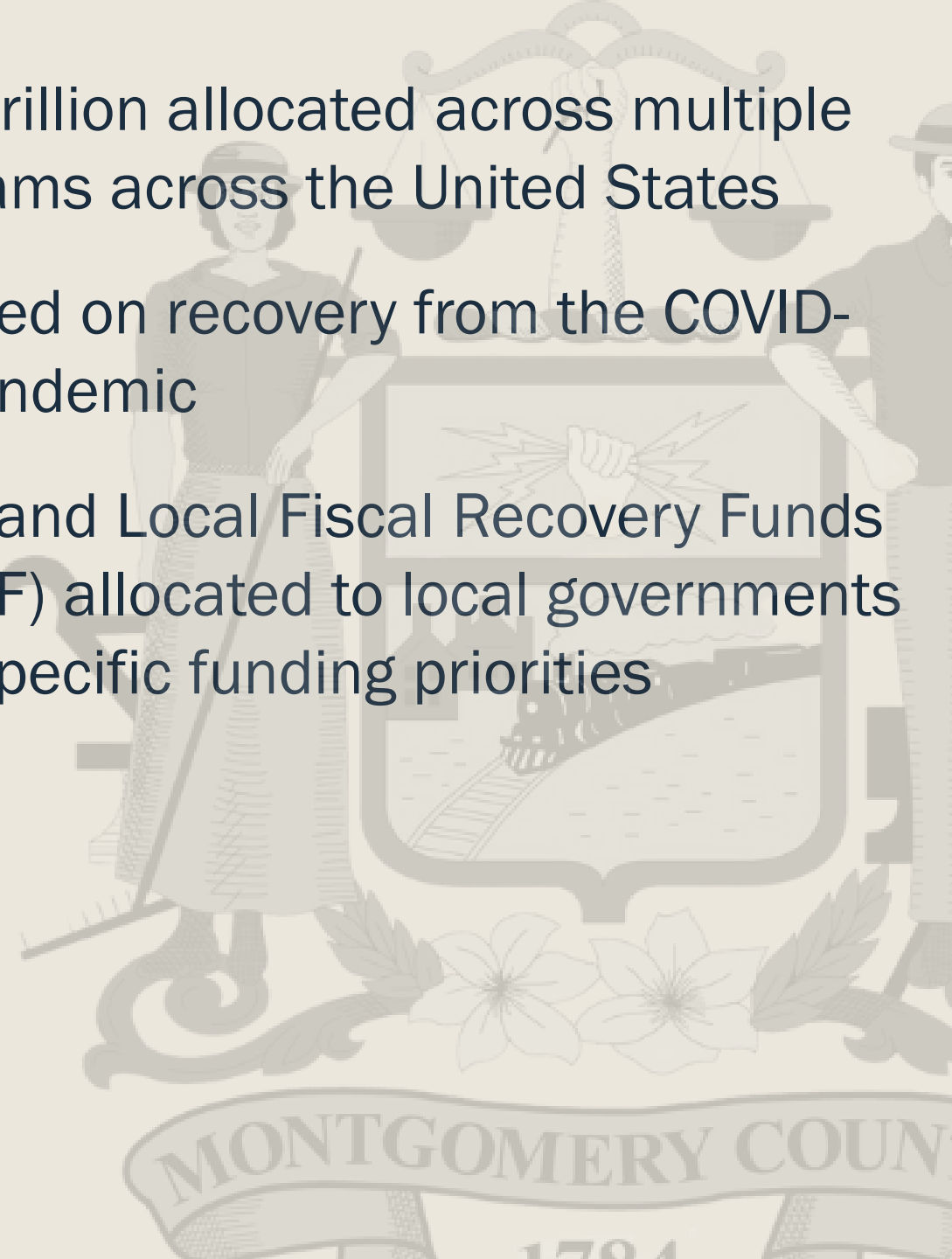

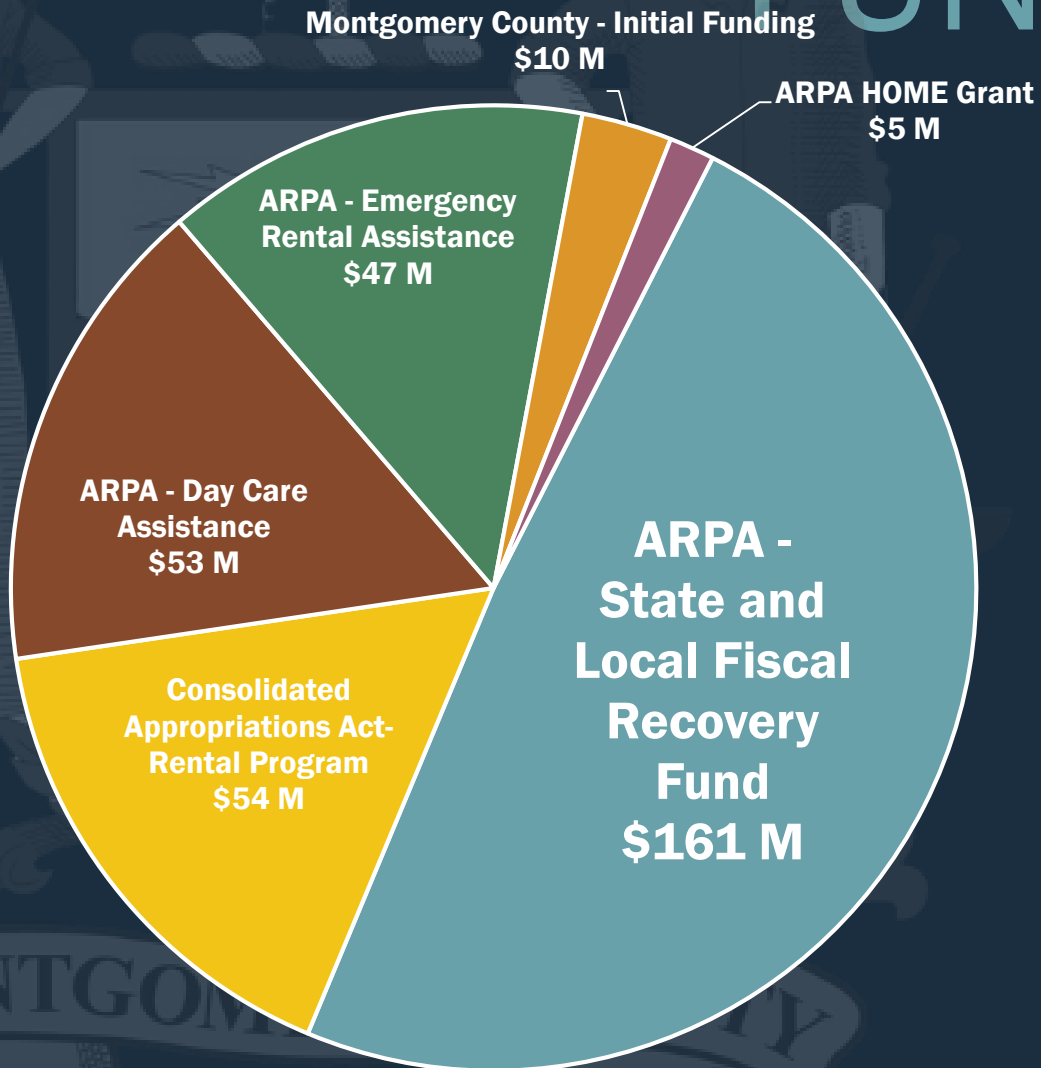
# WHAT IS ARPA?

The American Rescue Plan Act (ARPA) was signed into law March 11, 2021.

- \$1.9 trillion allocated across multiple programs across the United States
- Focused on recovery from the COVID-19 Pandemic
- State and Local Fiscal Recovery Funds (SLFRF) allocated to local governments with specific funding priorities

# ARPA FUNDING PRIORITIES

- Provide premium pay for essential workers
- Invest in water, sewer, and broadband infrastructure

# PURPOSE

Montgomery County will receive at least \$300 million new dollars across the next three years through various recovery funding programs. The County is positioned to institute bold initiatives that will advance equity, ensure economic recovery, invest in infrastructure and lay the groundwork for prosperity for decades.

Recovery Office is responsible for planning and executing projects that fulfill the purpose of the funding, have the intended impact, and can be completed successfully within the timeframe.

Building an implementable program of projects requires a professional, dedicated staff to ensure initiatives fulfill program goals, are well-planned, are executed and reported on transparently, and comply with legal and finance rules.

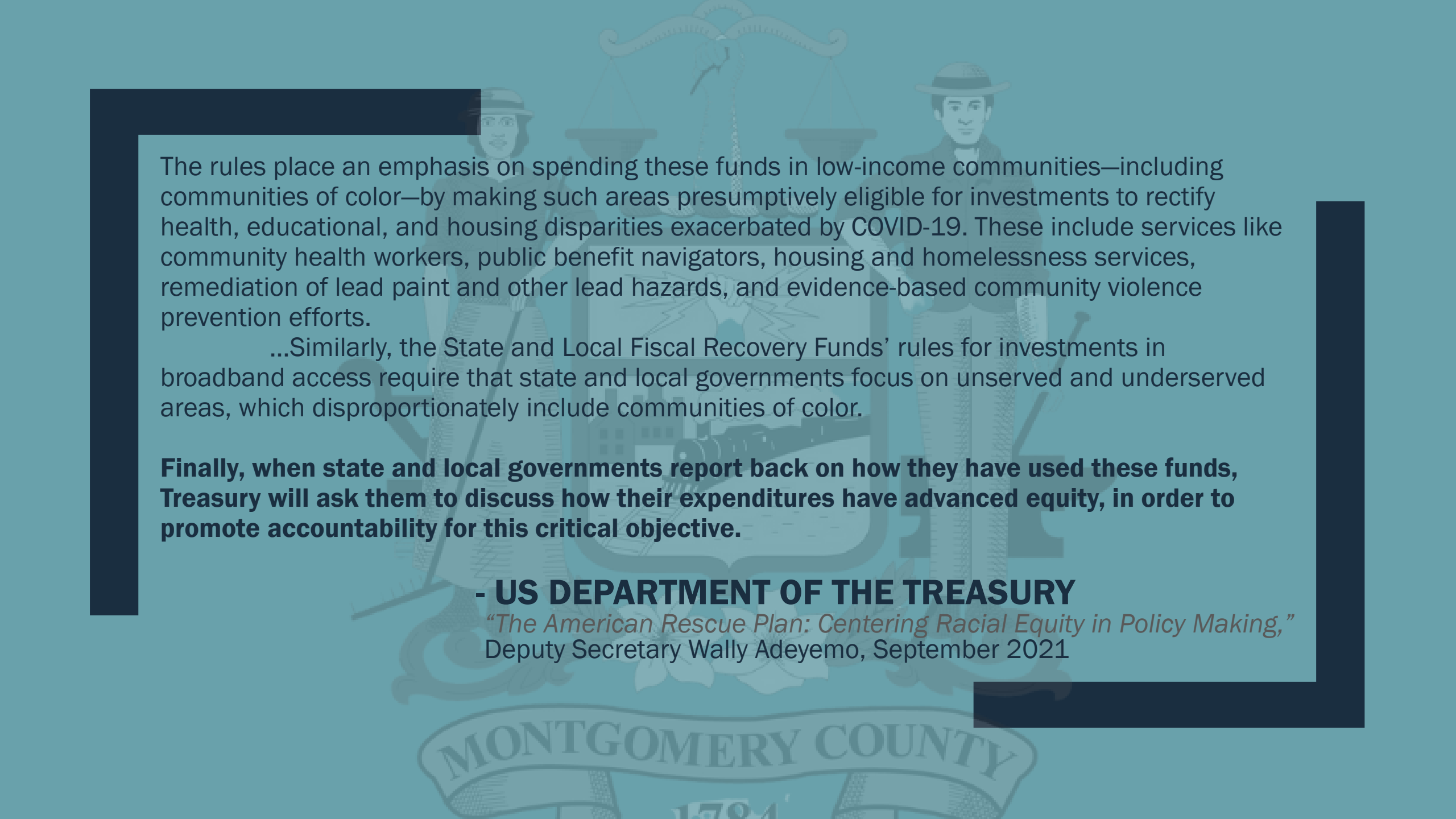

# PURPOSE

The Recovery Office can nimbly react to current and future funding with both incubated projects and the resources to make them happen.

Deliberate and regular engagement with a diverse group of internal and external stakeholders will create a consistent communication stream to convey efforts underway while identifying new pathways to augment recovery projects.



The rules place an emphasis on spending these funds in low-income communities—including communities of color—by making such areas presumptively eligible for investments to rectify health, educational, and housing disparities exacerbated by COVID-19. These include services like community health workers, public benefit navigators, housing and homelessness services, remediation of lead paint and other lead hazards, and evidence-based community violence prevention efforts.

...Similarly, the State and Local Fiscal Recovery Funds’ rules for investments in broadband access require that state and local governments focus on unserved and underserved areas, which disproportionately include communities of color.

**Finally, when state and local governments report back on how they have used these funds, Treasury will ask them to discuss how their expenditures have advanced equity, in order to promote accountability for this critical objective.**

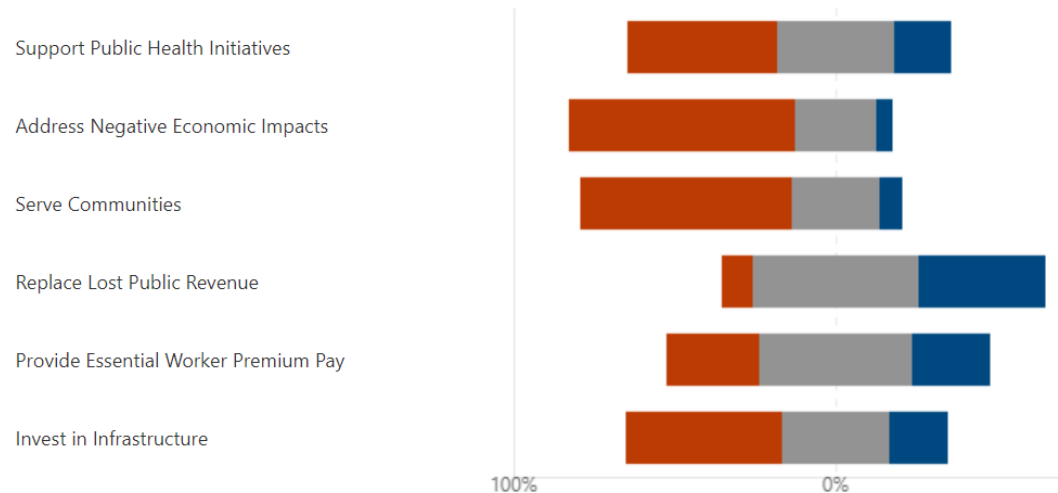

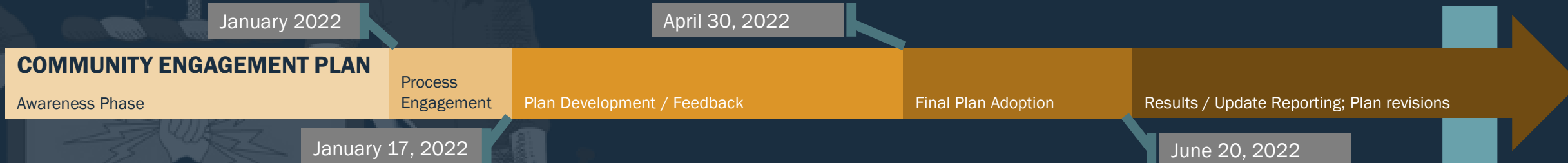

- Address the needs of people without housing
- Investments to address systemic public health challenges that have contributed to the unequal impact of the pandemic on underserved communities
- Increase funding for job training for individuals with disabilities
- Provide grants to small businesses that suffer from lost revenue due to pandemic
- Address disparities in public health, behavioral and mental health among Korean speaking population
- Lack of transportation options adversely impacts many disadvantaged populations
- Translation services for grant applications, official announcements, volunteer opportunities

## Awareness Phase

- Connect with groups and community leaders that the County may not have regular contact with
- Listen
- Inform process and planning
- Primary goal is to increase awareness, prepare for idea collection

## Process Engagement

- Assimilate what we heard into process document
- Assimilate US Treasury and government rules and guidance
- Produce final draft for distribution

## Plan Development / Feedback

- Collect submissions
- Engage in cycle of draft, feedback, revision
- Feedback-informed decisions
- Partner with community organizations to ensure full distribution, awareness, and input

## Final Plan Adoption

- Finalize plan
- County management approves plan, ensuring appropriate community input is incorporated

### SUBMISSION PROCESS

- Intake through web portal, third-party assistance for submissions
- Produces “apples to apples” project comparison documents
- Assessment tool metrics subject to feedback

### SUBMISSION REVIEW

- Submissions formatted as “pre-proposals,”
- Interested groups or individuals required to review guideline information, answer questions, submit data and financial plans, and provide brief narrative descriptions.
- Recovery Office personnel will communicate to produce fully detailed project proposal documents for consideration.

**May 15 through 31, 2022**

Draft recovery plan published for feedback

### RECOVERY PLAN

- Plan document establishes all projects funded by County State and Local Fiscal Recovery Funds (SLFRF)
- Provides plan for implementation by County staff and partners

# KEY EVALUATION CRITERIA

Each project will be evaluated by the Recovery Office team through the same objective criteria. Project submission process, forms and submitted projects will be available on OpenGov.

**All projects, regardless of source, will be evaluated using the same objective criteria.**

- Meet funding source requirements
- Align with County priorities
- Focus on underserved communities
- Equity impact
- Measurable Impact
- Budget Value/ROI
- One-Time funding OR sustainable business plan
- Leverage other resources

# PROJECT / PLAN PROCESS

County work to engage and solicit ideas and coordinated efforts with Municipal and School District partners will acknowledge the unique nature of such possibilities.

For example, the assessment of any municipal and / or school district project will necessarily involve understanding the role of County funds in augmenting, supplanting, or coordinating other allocations.

The County will through the Recovery Office work to collaborate cross-jurisdictionally to coordinate projects and planning, which may or may not mean consideration commitment of County SLFRF funds.

## 1. PROJECT / INITIATIVE ASSESSMENT

- Level, “apples to apples” objective comparison
- Includes key evaluation criteria and weighted analysis of priorities

## 2. REVIEW / APPROVAL OF ALL PROJECTS / PROGRAMS

- All scoring / rationale posted publicly

## 3. DOCUMENTATION OF PLAN, incorporated into Community Engagement process
