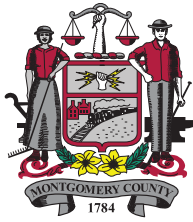

Professional Photography Session Permit

Thank you for your interest in having a photography session at Pottsgrove Manor! Photography sessions by a professional photographer cost **\$50** for up to two hours. This fee is to be paid in advance, at the time of registration.

- This fee is non-refundable, no matter what the weather or site conditions.
- This fee and permit does not guarantee exclusive access to any part of the facility.
- This fee and permit does not guarantee an exclusive time frame, other activities may be taking place in the facility at the time of your session.

Requirements

- The physical site (including plants) may not be altered in any way during the photo shoot.
- Any temporary props/scenery brought on site for the shoot must be completely removed at the end of site. All trash/debris must be removed.
- **Photo sessions limited to the hours the site is staffed (Tue.-Fri., 8:30 AM-4:30 PM, Sat. 9:30 AM-4:00 PM, Sun. 12:30 PM-4:30 PM).**
- Parking on site is limited.
- No photographs may be taken in the historic buildings.

Alcoholic Beverages

- There are NO ALCOHOLIC BEVERAGES allowed in this or any County historic site
- If you have any with you, keep them in the vehicle and do not consume them while you are on the grounds.
