**Six Montco deadbeat parents turn themselves in following last week's sweep**

**Norristown, Pa., (July 22, 2014)** – Six Domestic Relations Office “Wanted for Child Support” defendants, who owed a total of \$96,577.04 to eight children turned themselves in to the Montgomery County Sheriff’s Office over the days following a deadbeat parent raid on Wednesday, July 16, 2014. Five of the surrendered defendants have been released after resolving their cases.

Last week’s sweep arrests of six defendants represented \$59,777.07, which was owed to nine children. Four of those parents are still being held awaiting payment on their purge amounts.

Over 200 defendants, who have avoided making payments for their children, remain on the DRO’s list of parents wanted for non-payment of child support. Since finding and arresting deadbeat parents is a primary focus of the MCSO, deputies will continue to follow up on tips from the public in order to find and catch more delinquent parents.
