WEDDING/COMMERCIAL PORTRAIT PHOTOGRAPHERS
PERMIT REQUIRED

As of January 2009, County of Montgomery, Department of Parks, Trails and Historic Sites has instituted a fee schedule for wedding and commercial portrait photography by a commercial photographer at all County operated parks and historic sites, including:

PETER WENTZ FARMSTEAD

The permit application, along with a check for the fee, must be delivered at least one week in advance of the photography session.

The fee is \$50 for up to two hours.

PLEASE MAKE CHECK PAYABLE TO COUNTY OF MONTGOMERY

- Photo sessions must be held during the site's open hours:
 Tuesday - Saturday 10:00am to 4:00pm
 Sunday 1:00pm – 4:00pm
 The site is closed on Mondays and holidays.
- The fee is non-refundable. Exceptions will not be made for weather conditions.
- The fee and permit does not guarantee exclusive access to any part of the facility.
- The fee and permit does not guarantee an exclusive time frame. Other photography sessions and /or site activities may be taking place at the same time.

Parking:

- All vehicles (limos, wedding party cars, photographer's car, etc.) must be parked within the parking lot during open hours of the site (10:00am – 4:00 pm).
- All vehicles must be removed from the parking lot at 4:00pm when gates will be closed.
- Foot paths, gravel/dirt drives, service roads, and off road areas are off limits to all unauthorized vehicles.
- If handicapped accessibility is required please notify site staff at the time the permit application is submitted.
