**Montco Sheriff's Office gets two "Most Wanted" and one wanted on Norristown drug charges in DRO sweep**

**Norristown, Pa., (February 11, 2015)** – Deadbeat parents continue to be a target for the Montgomery County Sheriff's and Domestic Relations Offices. Six males, and one female parent representing 10 kids and \$81,657.40 in unpaid child support were arrested during an overnight raid. Judge Rhonda Daniele was scheduled to hear their cases.

"This week we are celebrating Valentine's Day, but we have no love for parents who avoid paying child support," said Sheriff Russell Bono.

Two of the male defendants in the sweep, including one that owed the largest arrearage of \$35,259.31, were on the list of "Most Wanted" for child support. Another male was taken into custody by Norristown Police Department for arraignment on drug charges. No other incidents were reported.

Twelve sheriff's deputies combed Harleysville, Royersford, Bridgeport, King of Prussia, Norristown and Abington areas with a list of 27 defendants, who represented \$246,122.28 in child support arrearages and 34 children.

"As always, I encourage defendants who have warrants for unpaid child support to turn themselves in, instead of being arrested at home or at work in front of family and friends," said Bono.
