Montco Sheriff's Office arrests nine in overnight DRO raid

Norristown, Pa., (May 6, 2015) – Montgomery County Sheriff Russell Bono’s deputies arrested eight male deadbeat parents and one female, who failed to pay a total of \$66,382.90 in child support for nine kids, during an overnight sweep on the early morning of May 6, 2015. Fourteen deputies, including K9 units, swept through Abington, Norristown, Horsham, Spring City, Royersford and Pottstown with a list of approximately 30 defendants. Five defendants listed below, who were not captured during the raid, are now on the “Most Wanted” list for child support.

“One of the defendants was found with an ounce of marijuana and five prescription pills,” said Bono. “We also had to force entry on a defendant with a probation violation, and one who was hiding in an attic.”

Since January 2015, the MCSO has arrested 300 deadbeat parents who collectively owe approximately \$4 million in child support.

“These overnight raids will continue on a regular basis,” MCSO Warrants Division Sgt. Joanne Plasterer said. “If you don’t want to see your picture on our website or on the news, just turn yourselves in.”
