Montco Sheriff's Office arrests eleven deadbeat parents in overnight DRO raid *Eleven others captured in a weeklong daytime effort in late September*

Norristown, Pa., (October 7, 2015) – Montgomery County Sheriff Russell Bono's deputies arrested eight males and three females, during an overnight sweep of deadbeat parents, who failed to pay a total of \$121,955.81 in child support for 18 kids. Starting on Wednesday, October 7, 2015 at 1:00 a.m., twelve deputies targeted Lower Merion, Norristown, Abington, Perkiomenville, Harleysville, Souderton, Pottstown, Spring City and Collegeville and arrested the following defendants:

"In late September, we tried a new strategy of concentrating on DRO warrant searches during the day for one week and we captured 11 defendants who owed \$62,791.65 for 14 kids," said Bono. "We will continue to try different approaches in order to bring these people in."
